- A copy of the Deed of Conveyance or a Bill of Sale is required for all property transfers before a Tax Certificate will be issued.
- Please provide a plot plan for sale/transfer where civic numbers are not assigned.
- For Sales of Commercial Properties which are Billed Water by Meter: Please send email to pwadmin@stjohns.ca and on the subject line enter, METER READ with the address of property. In the email, include the closing date of the sale and provide contact information to schedule access to the building to avoid unnecessary delays.
- **Commercial Property Sales**: It is the responsibility of the owner to ensure claims for vacancy allowance for the immediately preceding quarter are up to date. In the event of a sale, the vendor must adjust for vacancy allowance upon closing with the purchaser for the current quarter. Claims for current quarter must be claimed by purchaser with written confirmation from Lawyers that the claim was adjusted at sale closing.
